Overview

Mental illnesses are among the most common health conditions in the United States. Over 1 in 5 youth (ages 13-18) either currently or at some point during their life, have had a seriously debilitating mental illness. About 1 in 25 U.S. adults lives with a serious mental illness.

The 28th Annual Psychiatric Symposium will focus on improving psychiatric care through discussions on workplace violence in healthcare, strategies for engaging with difficult or dissatisfied patients, and updates and clinical management of schizophrenia and psychosis. Additionally, the symposium will explore understanding ethnic diversity and historical racial trauma in Black Americans, as well as the intersection of racism and ageism.


