OVERVIEW

This year's seminar will cover topics relevant to both health care and law. The intersection of health care and law is incredibly important since these two fields deeply influence each other and have a profound impact on individuals, communities, and society. Policies and law play a vital role in shaping health care systems. The relationship between both fields is dynamic and evolving and requires collaboration across disciplines to ensure the best outcomes for everyone. In this seminar, we will first look at ways for physicians and other health professionals to identify and manage stress to help reduce burnout in the industry. Second, participants will hear about strategies to recognize bullying and incivility in the workplace. They will discover how to assess for violence risks and to identify best practices to recognize and prevent potential threat or harm. Finally, we will hear most recent legal perspectives with case law updates on decisions that impact both health care professionals and attorneys. Medical malpractice lawsuits and medical-related legal decisions will be reviewed. Ultimately, the relationship between health care and law helps balance individual rights with societal needs, and it is vital for addressing the ethical, social, and regulatory challenges of modern medicine.
