#### **OVERVIEW**

This year's seminar will cover several New Frontiers related to the intersection of healthcare and law. First, we will look at Artificial Intelligence "Al" and medicine, including what we are seeing now and where this technology is expected to go. Second, participants will hear about the wearable devices, considering what products are medical grade FDA approved versus consumer facing, and the potential effect upon medical practices and lives.
